The undersigned represents and warrants to Pacific Food Distributors:

1. He/she is authorized to execute this application on behalf of Buyer.
2. The information set forth in this application is accurate and complete.
3. Buyer agrees that the prevailing party in any proceeding to enforce this Agreement or to resolve a dispute arising under this Agreement will be entitled to recover, in addition to costs, reasonable attorney fees incurred in the preparation, prosecution, or defense of any suit or action as determined by the court, and if any appeal is taken from such decision, reasonable attorney fees as determined on appeal.
4. Any action or proceeding to enforce any provision of, or based on any right arising out of, this Agreement will be brought against any of the parties in Multnomah County Circuit Court of the state of Oregon, and each party consents to the jurisdiction of such courts (and of the appropriate appellate courts) in any such action or proceeding and waives any objection to such jurisdiction and venue.
5. Buyer agrees to pay interest on any unpaid purchases, beginning 21 days after the payment due date at the rate of 1.5% per month, or the maximum judicial rate, whichever is less. Buyer also agrees to pay \$50.00 for each check issued by Buyer to Pacific Food Distributors, which is returned to Pacific Food Distributors unpaid or marked NSF. Pacific Food Distributors reserves the right to increase fees for unpaid or NSF checks without prior notice to Buyer.

In signing this application, Buyer agrees to all of the above and hereby grants permission for credit information to be verified by company (ies) and financial institution (s) that the Buyer has specified on this document and others that Pacific Food Distributors become aware of during the credit review process and from time to time.
